Hensel Phelps has a long and successful Design-Build history with WMATA, so when the subject contract was finally awarded and the Project Office was notified that Hensel Phelps was selected, we knew that the project would be designed, constructed and commissioned on time and with the quality we have come to expect from Hensel Phelps.

The design and construction of the new bus operations and maintenance facility was required to be completed no later than 660 calendar days after Notice to Proceed. The Program included a 250-bus facility, capable of accommodating standard, articulated, hybrid diesel/electric and CNG buses along with a goal of achieving LEED Silver Certification. Through well organized and detailed design meetings chaired by Hensel Phelps, WMATA Architects, Engineers, Maintainers and End Users were able to interact with the Design-Build Team to flesh out operations and maintenance requirements and subsequently attain a final design that optimized the functionality of the facility and still remain within the Project Budget.

The Hensel Phelps design included visually appealing and well executed Precast Concrete Building Facades which were approved by the US Commission of Fine Arts and the National Capital Planning Commission. The aforementioned approvals were key to securing timely permitting and start of construction.

During the course of construction, Hensel Phelps met the contract required DBE goals, planned and executed safe construction operations, and worked closely with WMATA to overcome several utility and jurisdictional coordination challenges to complete the project on time.
